

Alpha K9 U, LLC Off-Site (Off-Campus) Training Liability Release, 2024

ATTENTION: THIS IS A RELEASE OF LEGAL RIGHTS. PLEASE READ BEFORE SIGNING.

As part of off-site Alpha K9 U, LLC (Alpha K9 U) training, I have the opportunity to participate in various activities. To do so, I must agree to the following conditions: I understand and accept the inherent risks in dog obedience, dog games, dog competitions, and travel associated with off-campus training. I am voluntarily assuming these risks. I release Alpha K9 U, its employees, officers, Trustees, Directors, and assigns from any liability for any injury or loss I might incur during off-campus training. I, along with my heirs, executors, and administrators, waive and release any rights for claims and damages I may have against Alpha K9 U, its trustees, officers, employees, and agents, including the staff members and supervisors, due to any personal injury or property loss sustained by me during off-site activities and traveling to and from any off-campus program(s). I agree to adhere to the standards set for Alpha K9 U participants and follow the instructions of Alpha K9 U staff members. I understand that I am responsible for my safety and the safety of my dog(s).

Use of Dogs:

Regarding the use of dogs, I acknowledge that I have voluntarily applied to participate and use my dog(s) for off-campus training organized by Alpha K9 U. I understand that the act of leashing or accidentally unleashing my dog(s) and being physically present during such activities and trips carries inherent risks of injury to me, other people, my dog(s), and other dogs. I am fully responsible for these risks. I expressly accept all these risks. I also understand that dogs, regardless of their training and usual behavior, may act unpredictably at times due to circumstances, and I agree to accept this risk, which may include the presence of aggressive, vicious, and dangerous dogs in or around public areas.

I further understand and assume the risk that not all dogs present and present in the "general public" have received the Rabies vaccine as required by law and that not all dogs using "general public access areas" have been vaccinated for Distemper or Parvo all of which could result in injury to me and my dog(s).

Additional use of dogs risks include, but are not limited to, dog fights, dog bites and injuries to humans and other dogs; dog theft or unlawful capture; dog escape, plants and water sources in general areas that may be harmful to dogs; vegetation may have burrs or seeds that could become tangled in a dog's coat or lodge in a dog's feet, ears, nose, or eyes; mosquitoes, ticks, chiggers, fleas or other insects may be present; wild animals such as skunks, raccoons, opossums, or stray dogs could be present, all of which might injure or infect my dog(s). I understand and expressly assume all additional risks.

I understand that no agent or employee of Alpha K9 U cannot always supervise every team (dog/handler). I know neither Alpha K9 U nor any public access area(s) assumes liability for loss, damage, or injury sustained by any human or dog. I, therefore, expressly assume all risks associated with the Alpha K9 U class activities and field trips.

By signing this "release of liability," I fully and forever release and discharge Alpha K9 U and their employees and agents from any claims, demands, damages, rights of action, or causes of action present or future, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising out of my use or intended use of off-campus activities and general public access area(s) premises, facilities or equipment. I fully and forever release and discharge Alpha K9 U and its employees and agents from any negligent acts and omissions, and I intend to be legally bound by this release.

PLEASE BE ADVISED - The following dogs will NOT be allowed to participate in off-campus activities:

Dog aggressive dogs.

Dog's Name

- Aggressive dogs towards people.
- Bitches in season (heat).
- Dogs that appear to be ill or injured.
- Dogs that an instructor cannot examine.
- Dogs that the handler cannot control.
